"Vine has been an excellent local venue for artists and fans alike for live music in Long Beach for as long as I can recall. The previous owners made it very clear that respect for their neighbors was one of their top priorities, as they always had a hard cutoff in place for the closing band that was always much earlier than other similar venues. This awareness and tact has very clearly been transferred over to the new owners, who have proven to be just as sensible - they have continued to uphold these same noise restrictions and common sense curfews for live music.

I'm sorry this is so last-minute but I've only found out about the hearing as of last night With a neighbor brought it to my attention. As you can see from the attached photo the posting of their hearing is not at a normal level. The sidewalk is sloped in front of their business and they put it up even higher so when I walked by it's not even my level of sight. It's above my head. I'm not a small individual.

I've spoken with investigator Gonzalez numerous times on the phone and issued numerous complaints about the noise level smoke etc. emanating from this business. Even last night the night before their hearing, the band was playing until 1007. I have sent decibel level meter readings to investigator Gonzalez on different occasions notifying them of what's going on when no one is watching.

I would like to attend the hearing tonight but as it starts at 5 PM I do not get off work until 530. If you could please call me I would appreciate that my number is 619-847-5101.

I have several complaints from my neighbors who wish to remain anonymous in fear of retaliation of from the business as we are directly next door.

Dear Ms Voss,

I am writing as a reply to Notice of Public Hearing Entertainment Permit that came in mail concerning the issuance of a permit for Entertainment with Dancing by Patrons and Performers to Third Planet LLC, 2142 East 4th Street, Long Beach, CA 90814.

I live right next to this establishment and am gravely affected by its business conduct and am concerned about what this permit entails. Unfortunately, I won't be able to attend the hearing on November 16, 2021, and since the notice letter included your email, I am writing you instead.

First of all, the notice letter does not include any details on what this permit entails and what this business entity plans to do with it. What's more sensible to me is to include the business plan with the permit by the business operator so the neighboring residents can properly assess what impact it will have on the quality of their lives. I would still like to see the plan in writing before any decision is made, and hopefully you'd resend the notice with such crucial details to all the neighboring residents.

Secondly, before any further permits are acquired by Third Planet LLC, (Business name: Vine), it needs to address the current noise emittance problem. I observe that the business operators are making efforts to keep the front and the back door closed, but the level of the music they play, either live performances or amplified music, is utterly too loud to be contained by the establishment's current noise insulation efforts. The glass doors at the front and the back need to be replaced with more noise insulating material.

The noise I measured with doors closed read above 90 db by the front door (with door closed)

According to [Long Beach Municipal Code Title 8 - HEALTH AND SAFETY CHAPTER 8.80 - NOISE](#), the guideline show the noise limit for District Two are:

Night: 10:00 p.m. - 7:00 a.m. 55db

Day: 7:00 a.m.—10:00 p.m. 60db

Currently the noise level far exceeds this guidance and they need to mitigate as soon as possible. Until the establishment completes installation of the noise insulation to subdue the noise to the level in the guideline, they simply need to turn the volumes down, regardless of whether live performance or the amplified music, with all doors closed while music is playing.

In more personal language, the noise from the establishment is quite audible in our apartment, with our windows closed, and I feel very intrusive and affecting our mental and physical health.

Also, a simple comparison to the similar businesses on 4th street shows how lacking Third Planet LLC, (Vine)'s noise insulation effort is.

Also, the patrons in the patio (back of the establishment) are increasingly getting louder and louder. The business operator needs to control those who scream and yell. Posting a sign like "Be mindful of neighbors" may help but they need to make efforts like speaking to those who make such obnoxious noises.

Therefore, until these current issues are mitigated, I do not find issuance of any further business permits to this business entity is sensible or licit.

Also, I hope Third Planet LLC, (Vine) continues their efforts to prevent the formation of overflowing crowds on the side street and in the back patio and prohibit smoking near the adjacent residential buildings for its future operations.

Finally, before this request by the establishment is determined permissible, I would love for the written business plans along with the assurance that the failure to comply with the local ordinance and neglecting the environmental concerns stated above is a ground for business permit revocation, sent out to neighboring residents including myself.

Dear Mrs. Voss:

As trustees of the Grabowsky Family Trust, which owns the mixed use property at 2106-2108 E. 4th street, we are responding to the notice of public hearing which we received by mail.

It pertains to the issuance of a permit for Entertainment with Dancing by Patrons and Performers to Third Party Planet LLC, 2142 E. 4th street, Long Beach, CA 90814.

We are concerned about two issues:

The first issue is noise. Entertainment with dancing by patrons and performers also implies music at unspecified times. Many residents live in close proximity to the proposed location. Adding a dance venue with music would create a nuisance that would adversely affect the quality of life of those nearby residents.

The second issue is parking. There is no dedicated on-site parking available at 2142 E. 4th St. and patrons will be compelled to use street parking which now is shared by residents and short term business visitors. When large groups of patrons and performers will visit the venue, they will disproportionately use the scarce street parking as they will come at the same time. When parking spots are taken, other businesses will lose sales. This area of E. 4th St is very impacted and parking is hard to find. Allowing an entertainment and dance venue will make things worse.

Considering the above we feel that establishing an entertainment and dance venue at 2142 E. 4th St. would be inappropriate.

I'm writing to voice my dismay over wanting to expand a buissnes license to incorporate entertainment and dancing on 4th Street in Long Beach.

My concern is that 4th and Vine wine bar already has live bands that does not adhere to the noise ordinance of Long Beach:

"No person shall cause or permit loud music or other noises caused by a party, gathering or assemblage of persons on private property to disrupt the public peace. Noise that is audible from a distance of fifty feet (50') or more from the property shall be deemed to disrupt the public peace."

My apartment is more than 50 feet, yet through my closed windows and door, I hear their bands and patrons loud noises constant noise, well past 10pm. In additionally after closing hour's, this type of buissness has added to drunk and disorderly patrons yelling in the streets late unto the night.

Opening the permit to additional loud noise does not respect the neighborhood or the people already LIVE here. I am against this permit for do to the lack of respect of the buissnes, their patrons on neighborhoods current residents.
