As the United States, the City of Long Beach and the World look for sustainable futures, it is time to once again look at the operations of the Southeast Resource Recovery Facility (SERRF).

I firmly believe that the time has come for waste incinerators like the SERRF to be old technology. I encourage the City of Long Beach to use Amager Bakke ([https://en.wikipedia.org/wiki/Amager\\_Bakke](https://en.wikipedia.org/wiki/Amager_Bakke)) as a model for a replacement.

Amager Bakke located in Copenhagen is the world's first and only clean energy plant. The plant is similar in size to the SERRF in that it turns 400,000 tons of Copenhagen's waste into clean energy.

In addition to Amager Bakke there are additional ways to improve quality of life in the westside of Long Beach via implementing Green retrofitting ([https://en.wikipedia.org/wiki/Green\\_retrofit](https://en.wikipedia.org/wiki/Green_retrofit)) practices on current buildings. Green retrofitting increases the amount of green space within our city with the added value of reducing greenhouse emissions.

The westside of Long Beach is the ideal geographic footprint to utilize forthcoming infrastructure funding from the Federal Government. In addition, infrastructure funding can also be used to implement hydpanels (<https://www.source.co/how-hydropanels-work/>) and Blue spaces ([https://en.wikipedia.org/wiki/Blue\\_space](https://en.wikipedia.org/wiki/Blue_space)).

These new practices, being implemented in progressive sustainable cities throughout other geographic locations reducing the harm of environmental racism as noted in the newly released report "Vestiges of Environmental Racism: Closing California's Last Two Municipal Waste Incinerators" which examines the environmental, financial, and public health harms of municipal incinerators and kindly request the City Council to support the recommendations noted in the report.

Please direct City Staff to study these sustainable recommendations and how they can be implemented in our city with infrastructure funding. Hello,

The City of Long Beach needs to adopt a rent stabilization policy. We cannot build enough housing to relieve the shortage of affordable housing.

Landlords are raising rents an average of 20% in the last 10 years and the majority of Long Beach renters are rent-burdened, meaning they pay more than 30% of their monthly income toward rent.

It has been particularly hard on our Seniors who have a fixed income and often end up homeless.

We need Rent Stabilization to protect and stabilize our Long Beach citizens, 61% of them who are renters, from being displaced.

I urge City Council to direct the staff to adopt a Rent Stabilization Ordinance as a specific Policy or Program in the Housing Plan to prevent displacement and homelessness.
