You can easily create a path to the Port along the western border,Â going due south from Cabrillo High School and taking in the warehouses and commercial properties. This would have almost no impact on population.</p> <p>2. District A Panhandle To remove it, you could do a small rotation between Districts A,Â F, and B. It would unify the Downtown neighborhood by pushing A up to Anaheim on the east side, extending Cambodiatown east to Obispo, and having B absorb the panhandle.</p> <p>3. On the border between Districts I and H, on the westside, there is a small neighborhood that's cut off from the district by the 91 highway.
