SECOND AMENDMENT TO AGREEMENT NO. 35086

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35086 (the "Agreement") whereby Consultant agreed to provide municipal residential and commercial solid waste handling services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to October 31, 2021, add additional services, amend the rate schedule, update Consultant's Key Employee, and add the authorized annual amount of \$1,985,500; and

WHEREAS, the Parties desire to add the authorized annual amount of \$1,985,500, extend the term one (1) additional one-year period, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on November 1, 2018, and shall terminate at 11:59 p.m. on October 31, 2022, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended one (1) additional one-year period, at the discretion of the City Manager."
