SECOND AMENDMENT TO AGREEMENT NO. 35221

35221

THIS SECOND AMENDMENT TO AGREEMENT NO. 35221 is made and entered, in duplicate, as of November 10, 2021, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 17, 2020, by and between AECOM TECHNICAL SERVICES, INC., a California corporation ("Consultant"), with a place of business at 401 West A Street, Suite 1200, San Diego, California 92101, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35221 (the "Agreement") whereby Consultant agreed to provide on-call environmental, planning, affordable housing, and community engagement consultant services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to March 5, 2022 and update Consultant's key employee; and

WHEREAS, the Parties desire to add \$50,000 to the Agreement for a total not to exceed amount of \$100,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Hundred Thousand Dollars (\$100,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35221 are ratified and confirmed and shall remain in full force and effect.
