

SECOND AMENDMENT TO AGREEMENT NO. 35115

THIS SECOND AMENDMENT TO AGREEMENT NO. 35115 is made and entered, in duplicate, as of November 4, 2021, for reference purposes only, pursuant to Resolution No. RES-18-0150, adopted by the City Council of the City of Long Beach at its meeting on October 2, 2018, by and between ZOLL MEDICAL CORPORATION, a Massachusetts corporation ("Contractor"), with a place of business at 269 Mill Road, Chelmsford, Massachusetts 01824, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35115 (the "Agreement") whereby Contractor agreed to provide to the Long Beach Fire Department additional units, parts and accessories compatible with their 12-lead electrocardiogram defibrillator units; and

WHEREAS, the Parties entered into a First Amendment to extend the term one additional one-year period; and

WHEREAS, the Parties desire to extend the term for one additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein the Parties agree as follows:

1. Section 3 of the Agreement is hereby amended to read as follows:

"3. The term of this Contract shall commence on November 1, 2018, and shall terminate at midnight on October 31, 2022, unless sooner terminated as provided herein. The Parties have the option to extend the term for one (1) additional one-year periods. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35115 are ratified and confirmed and shall remain in full force and effect.

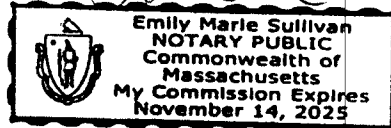

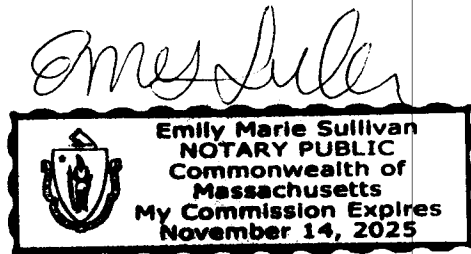
