## FIRST AMENDMENT TO AGREEMENT NO. 35529

THIS FIRST AMENDMENT TO AGREEMENT NO. 35529 is made and entered, in duplicate, as of December 21, 2021 for reference purposes only, pursuant to Resolution No. RES-20-0021, adopted by the City Council of the City of Long Beach at its meeting on February 4, 2020, by and between ASSETWORKS LLC, a Delaware limited liability company ("Contractor"), with a place of business at 998 Old Eagle School Rd, Suite 1215, Wayne, PA 19087, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35529 (the "Agreement") whereby Contractor agreed to provide software, hardware, and related services for continued support for the M-5 Fleet Management database; and

WHEREAS, the Parties desire to extend the term of the Agreement for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 3 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> Notwithstanding anything to the contrary in any exhibit, the term of this Agreement shall commence at midnight on February 4, 2020 and shall terminate at 11:59 p.m. on and shall terminate at midnight on February 3, 2023 provided, however, that the license granted in Section 5 below shall be perpetual unless specifically terminated by either party. City shall have the option to extend the term of this Agreement for two (2) additional one-year periods, at the discretion of the City Manager. The City may terminate this Agreement by giving thirty (30) days prior notice of termination to Contractor."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35529 are ratified and confirmed and shall remain in full force and effect.
