#### FIRST AMENDMENT TO AGREEMENT NO. 35386

THIS FIRST AMENDMENT TO AGREEMENT NO. 35386 is made and entered, in duplicate, as of December 13, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 20, 2019, by and between FORENSIC NURSING SPECIALIST, INC., a California corporation ("Consultant"), with a place of business at 10413 Los Alamitos Blvd., Los Alamitos, California 90720, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing medical examinations, evidence collection, and treatment for victims of sexual assault; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35386 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to extend the term of the Agreement for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on October 31, 2019, and shall terminate at 11:59 p.m. on October 30, 2022. City shall have the option to extend the term of this Agreement for one (1) additional one-year period, at the discretion of the City Manager."

- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35386 are ratified and confirmed and shall remain in full force
