

### FILING SCHEDULE, FEES & DISCLOSURE REQUIREMENTS



Registration due within 15 days of qualifying (LBMC 2.08.030) Current Filers = 22

Initial Registration:Due January 15Covers activity period between July & DecemberList all clients covered in the activity period

Semi-Annual:

Due July 15 – Reduced Fee after July 1<sup>st</sup> Covers activity period between January & June List all clients covered in the activity period
