FOURTH AMENDMENT TO LEASE NO. 32944

THIS FOURTH AMENDMENT TO LEASE NO. 32944 is made and entered, in duplicate, as of August 31, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on January 21, 2020, by and between FRIENDS OF COLORADO LAGOON, a nonprofit for public benefit corporation ("Lessee") whose address is 6475 Pacific Coast Highway, #252, Long Beach, California 90803, and the CITY OF LONG BEACH, a municipal corporation ("City" or "Lessor").

WHEREAS, Lessee is dedicated to promoting the maintenance of the Colorado Lagoon in tandem with the Department of Parks, Recreation and Marine ("Department") to ensure a healthy balance between recreation, flood management, water quality, wildlife habitat, and native plants at the Lagoon, as well as Lagoon restorationrelated activities including re-vegetation, fundraising and general advocacy; and

WHEREAS, Lessee and Lessor (the "Parties") executed Lease No. 32944
(the "Lease") wherein Lessor agreed to lease Lessee a facility commonly known as the
Colorado Lagoon Wetland and Marine Science Education Center, located at 5119 E.
Colorado Street, from which to provide such activities; and

19WHEREAS, the Parties entered into a First Amendment to the Lease to20extend the term to September 30, 2016; and

21 WHEREAS, the Parties entered into a Second Amendment to the Lease to 22 extend the term to September 30, 2018; and

23 WHEREAS, the Parties entered into a Third Amendment to the Lease to 24 extend the term to September 30, 2021 and amend various provisions of the Lease;

WHEREAS, the Parties desire to again extend the term;
