AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY ADDING SECTION 8.68.066 AND SUBSECTION 8.68.120.C RELATING TO SMOKING PROHIBITED IN CITY PARKS AND OTHER RECREATION AREAS

The City Council of the City of Long Beach ordains as follows:

12 Section 1. Section 8.68.066 is added to the Long Beach Municipal Code to read as follows:

> 8.68.066 Smoking prohibited – City parks and other recreation areas.

Α. Smoking shall be prohibited in any outdoor area that has been improved or developed by or on behalf of the City, and open to the general public for park or open space use, including, but not limited to public parks, picnic areas, playgrounds, sports or playing fields, walking paths, gardens, hiking trails, bike paths, and any other areas designated a park by the Director of the Department of Parks and Recreation.

Β. The provisions of this Section shall not apply to Municipal golf courses, or permitted activities, including, but not limited to filming and/or special events.

25 Section 2. Subsection 8.68.120.C is added to the Long Beach Municipal 26 Code to read as follows:
