

FIRST AMENDMENT TO AGREEMENT NO. 35472

THIS FIRST AMENDMENT TO AGREEMENT NO. 35472 is made and entered, in duplicate, as of December 16, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 21, 2020, by and between HNTB CORPORATION, a Delaware corporation ("Consultant"), with a place of business at 601 W. 5th Street, Los Angeles, California 90071, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35472 (the "Agreement") whereby Consultant agreed to provide as-needed planning and design engineering services for various development projects at the Long Beach Airport; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on February 21, 2020, and shall terminate at 11:59 p.m. on February 20, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35472 are ratified and confirmed and shall remain in full force and effect.
