ORDINANCE NO. 1 2 3 AN ORDINANCE OF THE CITY COUNCIL OF THE 4 CITY OF LONG BEACH AMENDING CHAPTER 16.16 OF 5 THE LONG BEACH MUNICIPAL CODE BY ADDING 6 SECTION 16.16.140 RELATING TO PROHIBITING ADULTS 7 NOT ACCOMPANYING CHILDREN UNDER THE AGE OF 12 8 FROM PARK PLAYGROUNDS 9 10 WHEREAS, safe outdoor spaces are vital to the healthy development of 11 children, as they provide exercise and recreation areas, emotional and social enrichment 12 opportunities, and promote community use of public green spaces; and 13 WHEREAS, in playground design, everything from the height of the structure 14 to the type of surfacing used is based on guidelines that reflect use by toddlers and children 15 aged 2 to 5 and/or 5 to 12 years old; and 16 WHEREAS, adult use of playground equipment can result in structural 17 damage that may lead to safety hazards for the children who use the equipment after them; 18 and 19 WHEREAS, residents of the City of Long Beach ("City") have recently 20 reported adults misusing public playground spaces by engaging in other activities that 21 discourage proper use by children and their guardians; and 22 WHEREAS, given the recent upticks in vandalism and damage, and resident 23 concerns about the safety and availability of the City's playgrounds to children, it is 24 necessary for the City to promote measures for safe outdoor spaces; and 25 WHEREAS, one such measure is to establish "kids zones," at park 26 playgrounds, in which an adult not accompanying a child under the age of 12 is prohibited 27 from entering, which would seek to ensure the City's playground equipment and play areas 28 specifically designed for children remain safe and available spaces for use by children of 1

the aforementioned age groups; and 1

WHEREAS, these kids zones would be easily identifiable and enforceable 2 with signage identifying the zone area; and 3

WHEREAS, these kids zones would not cover other non-playground public 4 spaces in parks, including, but not limited to, benches, fields, and restrooms; and 5

WHEREAS, in establishing an ordinance prohibiting adults from entering or 6 remaining within these designated areas without accompanying a child under the age of 12, the City would be following suit of other jurisdictions in California, New York, Oregon, 8 Colorado, and Florida, in an effort to preserve such spaces and equipment for children for 9 which they were intended; 10

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 16.16.140 entitled "Park Playgrounds—Adults not accompanying children under the age of 12 prohibited" is hereby added to Chapter 16.16 of the Long Beach Municipal Code to read as follows:

16.16.140 – Park Playgrounds—Adults not accompanying children under the age of 12 prohibited.

Α. No adult shall be present on any City park playground unless the adult is accompanying a child or children under the age of 12, lawfully under their custody or control, including a parent or guardian, babysitter, caretaker or other designee of a parent or guardian having sole or joint supervisory responsibility over the child, using such playground.

Β. "Park playground" or "playground" for purposes of this section means any park area which has been designated by the Department of Parks, Recreation and Marine Director, or designee, as a "Kids Zone", and on which clear and visible signage has been posted providing notice of such "Kids Zone" status and the prohibition in subsection A.
