## FIRST AMENDMENT TO AGREEMENT NO. 35884 35884

THIS FIRST AMENDMENT TO AGREEMENT NO. 35884 is made and entered, in duplicate, as of March 24, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 16, 2021, by and between PC SPECIALISTS, INC. DBA TECHNOLOGY INTEGRATION GROUP, a California corporation ("Consultant"), with a place of business at 10240 Flanders Court, San Diego, California 92121, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35884 (the "Agreement") whereby Consultant agreed to provide personal computer replacement and installation services; and

WHEREAS, the Parties desire to include the contingency amount and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed Five Hundred Forty Thousand Dollars (\$540,000), with a fifteen percent (15%) contingency in the amount of Eighty One Thousand Dollars (\$81,000), for a total not to exceed amount of Six Hundred Twenty-One Thousand Dollars (\$621,000) for the year ending April 14, 2022; and thereafter, in an annual amount of Two Hundred Seventy Thousand Dollars (\$270,000), with a fifteen percent (15%) contingency in the amount of Forty Thousand Five Hundred Dollars (\$40,500), for an annual contract amount not to exceed Three Hundred Ten Thousand Five Hundred Dollars

(\$310,500), at the rates or charges shown in Exhibit "B"."

- 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on April 15, 2021, and shall terminate at 11:59 p.m. on April 14, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for three (3) additional one-year periods, at the discretion of the City Manager."
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35884 are ratified and confirmed and shall remain in full force and effect.
