

FIRST AMENDMENT TO AGREEMENT NO. 35515

THIS FIRST AMENDMENT TO AGREEMENT NO. 35515 is made and entered, in duplicate, as of March 3, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 4, 2020, by and between NANCY K. BOHL, INC. DBA THE COUNSELING TEAM INTERNATIONAL, a California corporation ("Contractor"), with a place of business at P.O. Box 10427, San Bernardino, CA 92423,, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with pre-employment psychological examination services ("Project"); and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35515 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to enter into a First Amendment to extend the term for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Agreement is hereby amended to read as follows.

"2. TERM. The term of this Agreement shall commence at midnight on February 4, 2020, and shall terminate at 11:59 p.m. on February 3, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. This Agreement may be extended for two (2) additional one (1) year periods, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35515 are ratified and confirmed and shall remain in full force and effect.
