14	35983 (the "Agreement") whereby Consultant agreed to provide these services; and
15	WHEREAS, the Parties entered into a First Amendment to amend the scope
16	of work and budget;
17	WHEREAS, the Parties entered into a Second Amendment to extend the
18	term of the contract and increase the contract amount by Three Thousand Two Hundred
19	Sixty-Two Dollars (\$3,262) for a new total amount contract of Eighty-Eight Thousand Eight
20	Hundred Sixty-Two Dollars (\$88,862); and
21	WHEREAS, the Parties currently desire to extend the contract for an
22	additional one-year period;
23	NOW, THEREFORE, in consideration of the mutual terms, covenants, and
24	conditions herein contained, the Parties agree as follows:
25	1. Section 2. of the Agreement is hereby amended to read as follows.
26	"The term of this Agreement shall commence at midnight on July 1, 2021,
27	and shall terminate at 11:59 p.m. on March 31, 2023, unless sooner terminated as provided
