

FIRST AMENDMENT TO AGREEMENT NO. 35516

THIS FIRST AMENDMENT TO AGREEMENT NO. 35516 is made and entered, in duplicate, as of March 3, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on February 4, 2020, by and between PSYCHOLOGICAL CONSULTING ASSOCIATES, INC., a California corporation ("Contractor"), with a place of business at 10940 Wilshire Blvd., Suite 1600, Los Angeles, CA 90024, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with pre-employment psychological examination services ("Project"); and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35516 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to enter into a First Amendment to extend the term for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.

"2. TERM. The term of this Agreement shall commence at midnight on February 4, 2020, and shall terminate at 11:59 p.m. on February 3, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. This Agreement may be extended for two (2) additional one (1) year periods, as approved by the City."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35516 are ratified and confirmed and shall remain in full force and effect.
