Alvin Teng presented on the Homekey Operating Subsidy Commitment. Somatra Church provided additional information. City of Long Beach plans to apply for funding from the Homekey Program Round 2 for the following projects: Modular Non-Congregate Shelter Program (i.e. "Tiny Homes") (30-35 Shelter Units at the Long Beach Multi-Service Center for interim housing) and Motel Acquisition and Conversion for Interim Housing (3 potential properties identified, still in negotiation/selection). To qualify for operating subsidies, the Long Beach CoC must approve a letter of support that commits to funding the cost of operations.

On Sept 2021 - Governor Newsom announced \$1.45 billion for Homekey Round 2. All funds must be used to provide housing for individuals and families experiencing or at risk of homelessness and impacted by the COVID-19 pandemic. Provided overview of eligible uses such as acquisition of motels or other assets that could be converted to permanent or interim housing. Provided summary of maximum grant amounts: Capital Award (Per Door): \$150,000-\$200,000 and Operating Award (Per Unit): \$1,000-\$1,400 per month. Discussion ensued among the Board Members.

Somatra Church presented on HHAP Round 3. Paul Duncan provided additional information. HHAP application is due by June 30, 2022. Requires planning and input process to create/update a local homelessness action plan, along with goals. HSB has done initial engagement with the Homeless Coordination and Finance Council to discuss application and planning process. 4th Annual allocation of funding from the State. 3rd Round under the HHAP program. Funding allocation to Long Beach CoC and City of Long Beach is a total of \$8.5 million. Must participate in the statewide Homeless Data Integration System. As part of the planning process, the HSB plans to hold several community input sessions. Input sessions will include persons with lived expertise, service providers, and community stakeholders.

The HSB recommended the creation of an ad hoc committee to set community goals around addressing homelessness. The following Board Members volunteered to participate in the ad hoc committee: Dianka Lohay, Jordan Wynne, Luther Richert, and Jamies Shuford. At the June 14th CoC Board meeting the finalized plan and proposal being recommended will be presented for a vote.
