21	conditions herein contained, the Parties agree as follows:

25	reference, in accordance with the standards of the profession, and City shall pay for
26	these services in the manner described below, not to exceed Two Hundred Twenty
27	Thousand Dollars (\$220,000), at the rates or charges shown in Exhibit "B"."
