

SECOND AMENDMENT TO PERMIT NO. 34476

THIS SECOND AMENDMENT TO PERMIT NO. 34476 is made and entered, in duplicate, as of June 10, 2022 for reference purposes only, pursuant to Section 16.16.060 of the Long Beach Municipal Code, by and between the PARKS AND RECREATION COMMISSION OF THE CITY OF LONG BEACH, CALIFORNIA, through the Director of the Department of Parks, Recreation and Marine ("Director") and LONG BEACH LAWN BOWLING CLUB, INC., a California nonprofit corporation ("Permittee"), whose address is 1109 Federation Drive, Long Beach, California 90804.

WHEREAS, the Commission acting through the Director has granted to Permittee permission to use the Permit Area for the purpose of recreational lawn bowling and other activities related to lawn bowling, and Permittee has requested to continue such operation under Permit No. 34476 and the Director is willing to permit this continued operation under the Permit; and

WHEREAS, the parties entered into a First Amendment to Permit No. 34476 to extend the term through August 31, 2022; and

WHEREAS, the parties again desire to extend the term for one (1) additional three-year term through August 31, 2025;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Permit No. 34476, the parties agree as follows:

1. Section 3A of Permit No. 34476 is hereby amended in its entirety to read as follows:

"3. TERM.

A. The term of this Permit shall commence at midnight on September 1, 2016, and shall terminate at 11:59 p.m. on August 31, 2025, unless sooner terminated as provided in this Permit."

2. Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 34476 are ratified and confirmed and shall remain in full force
