

WHEREAS, on July 5, 2022, City Council approved extending the Agreementone (1) additional one-year period; and

WHEREAS, the Parties desire to add Two Hundred Fifty Thousand Dollars
(\$250,000) for a total not to exceed amount of Eight Hundred Fifty Thousand Dollars
(\$850,000), extend the term one (1) additional one-year period, update the City
Representative and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and
conditions herein contained, the Parties agree as follows:

Section 1.A. of the Agreement is hereby amended to read as follows:
 "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Eight Hundred Fifty Thousand Dollars (\$850,000), at the rates or charges shown in Exhibit "B"."

2. Section 2 of the Agreement is hereby amended to read as follows:

16 "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
17 July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2023, unless sooner terminated
18 as provided in this Agreement, or unless the services or the Project is completed sooner.<sup>n</sup>

The Rates contained in Exhibit "B" to the Agreement are hereby
 amended and replaced by Exhibit "B-1", attached hereto and incorporated herein.

4. The City Representative in Exhibit "C" to the Agreement is hereby
amended in accordance with Exhibit "C-1", attached hereto and incorporated by this
reference.

5. Except as expressly modified herein, all of the terms and conditions
contained in Agreement No. 33926 are ratified and confirmed and shall remain in full force
and effect.


