### Real Property Management


- Engineering Bureau took over Real Property Management in March 2022
- LBWD-owned properties include the following:

  - > Treatment Plant
  - 2 Reservoir Sites (Alamitos & JWJ)
  - > 32<sup>nd</sup> St. and St. Louis
  - > 32<sup>nd</sup> St. Booster (Potable) Pump Station
  - > Parcels near and around the Treatment Plant and airport area
  - > 30 Well sites, 29 Sewer Lift Station sites, 4 Reclaimed Pump Station sites, and 10 MWD Connection sites

### **Executive Summary**

#### December 2019

- Board authorized the GM to negotiate / execute RFUP with CIT
  - 52,500 sq. ft. of space at St. Louis Ave. and 32<sup>nd</sup> St.
  - Interim location for hands-on trucking and heavy equipment training
  - Fair Market Value rental rate minus training credits
  - Term: January 31, 2020 February 27, 2022

#### • March 2022

- CIT requested for a 6-month extension
  - New Term: February 28, 2022 August 27, 2022



### 2<sup>nd</sup> Request for Term Extension

- LBWD received CIT's request for RFUP extension in June 2022
  - Plans in securing permanent location fell through with City of Long Beach Planning and zoning issues
  - > Extension period 12 months
  - > Rental rate Increase due to credit reduction
    - Training credits will be half of the previous annual amount
  - New Term August 28, 2022 to August 31, 2023

## Fiscal Impact

- Monthly rental rate of \$7,875
- Revenue to Water Fund:
  - > Total of \$94,500 for the 12-month period
    - FY 22 \$7,875
    - FY 23 \$86,625
    - Calculated based on the annual fair market value rental rate of \$132,300 minus the annual training rental credit of \$37,800
  - > Rent charged prorated if property is vacated early



### Recommendation

Authorize the General Manager to extend the executed Revocable Facilities Use Permit with the College of Instrument Technology for an additional twelve (12) months to allow continued use of 52,500 sq. ft. of space at Long Beach Water Department-owned property at St. Louis Avenue and 32<sup>nd</sup> Street, as an interim location for its hands-on trucking and heavy equipment training.
