FOURTH AMENDMENT TO AGREEMENT NO. 34656

34656

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34656 is made and entered, as of June 22, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 21, 2022, by and between KAMUS KELLER, INC., a California corporation ("Consultant"), with a place of business at 111 W. Ocean Blvd. Suite 1750, Long Beach, CA 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34656 (the "Agreement") whereby Consultant agreed to provide as needed urban planning design services for a period of two (2) years with the option to renew for three (3) additional one-year periods in an amount not to exceed Six Hundred Thousand Dollars (\$600,000);

WHEREAS, the Parties entered into a First Amendment to the Agreement to add One Million Dollars (\$1,000,000) for a total not to exceed amount of One Million Six Hundred Thousand Dollars (\$1,600,000) and extend the term to June 30, 2020;

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to June 30, 2021;

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to June 30, 2022;

WHEREAS, on June 21, 2022, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties desire to also update the City Representative and attach an updated rate sheet.

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:
2. TERM. The term of this Agreement shall commence at midnight on July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2023, unless sooner terminated

2 2. The Rates contained in Exhibit "B" to the Agreement are hereby
3 amended and replaced by Exhibit "B-1", attached hereto and incorporated herein.

4 3. The City Representative in Exhibit "C" to the Agreement is hereby
5 amended in accordance with Exhibit "C-1", attached hereto and incorporated herein.

6 4. Except as expressly modified herein, all of the terms and conditions
7 contained in Agreement No. 34656 are ratified and confirmed and shall remain in full force
8 and effect.
