## FIRST AMENDMENT TO AGREEMENT NO. 36248

# 

THIS FIRST AMENDMENT TO AGREEMENT NO. 36248 is made and entered, as of June 29, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 21, 2022, by and between SO. CAL. SEWER CONSTRUCTION, INC., doing business as SOCAL SEWER & WATER, a California corporation ("Contractor"), with a place of business at 3289 Industry Drive, Signal Hill, California, 90755, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 36248 (the "Agreement") whereby Contractor agreed to provide on-call plumbing maintenance and repair services, and emergency plumbing services in the amount of Five Hundred Nine Thousand Dollars (\$509,000) for a period of two (2) years with the option to extend for three (3) additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties desire to increase the annual amount by One Hundred Sixteen Thousand Dollars (\$116,000) for a total not to exceed annual amount of Six Hundred Twenty-Five Thousand Dollars (\$625,000);

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Contractor shall furnish specialized services more particularly described in Exhibit "A-2", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in a total annual amount not to exceed Six Hundred Twenty-Five Thousand Dollars (\$625,000), at the rates or charges shown in Exhibit "B"."
- 2. Except as expressly amended herein, all terms and conditions in Agreement No. 36248 are ratified and confirmed and shall remain in full force and effect.




