3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35394 is made and 4 entered, as of July 14, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 20, 2019, 5 by and between ARDURRA GROUP, INC. DBA ANDERSONPENNA PARTNERS, a 6 7 Florida corporation ("Consultant"), with a place of business at 3737 Birch Street, Suite 250. 8 Newport Beach, California 92660, and the CITY OF LONG BEACH, a municipal 9 corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35394 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call 12 consulting services for street design projects in an amount not to exceed One Million Dollars (\$1,000,000) for a period of three (3) years with the option to extend for two (2) 14 additional one-year periods, at the discretion of the City Manager; and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to 16 add One Million Dollars (\$1,000,000) for a total not to exceed amount of Two Million Dollars 17 (\$2,000.000); and

18 WHEREAS, on August 10, 2021, City Council authorized increasing the 19 aggregate agreement amount by Twenty Million Dollars (\$20,000,000) for a revised 20 aggregate agreement amount not to exceed Thirty Million Dollars (\$30,000,000); and

21 WHEREAS, the Parties entered into a Second Amendment to the Agreement 22 to add Five Million Dollars (\$5,000,000) for a total not to exceed amount of Seven Million 23 Dollars (\$7,000,000); and

24 WHEREAS, the Parties desire to extend the term one (1) additional one-year 25 period, attach an updated rate sheet, and update the City Representative;

26 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 27 conditions herein contained, the Parties agree as follows:


