THIS FIRST AMENDMENT TO AGREEMENT NO. 35113 is made and entered, in duplicate, as of May 10, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 9, 2018, by and between MUNICIPAL EMERGENCY SERVICES, INC., a Nevada corporation ("Contractor"), with a place of business at 4343 Viewridge Avenue, Suite A, San Diego, CA 92123, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City desires to purchase fire turnouts, turnout coats and pants for the Long Beach Fire Department; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35113 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties desire to enter into a First Amendment to extend the term of the Agreement for an additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2. of the Agreement is hereby amended to read as follows.
- "2. The term of this Agreement shall commence at midnight on November 1, 2018, and shall terminate at 11:59 p.m. on December 31, 2022, with the option to renew for as long as the MES Agreement is in effect, at the discretion of the City Manager."
