  - The Board went over a few items in preparation for the annual CoC Competition. They were given the priority areas in preparation for the ranking and reviewing of CoC programs
  - Lived Experience Board will be established soon.
  - They were also given the Homeless Count Point-in-Time Presentation.

#### UNITED WAY PRESENTATION

Chair Julie Lie introduced the two presenters representing United Way, Jordan Wynne, Community Activation Specialist and Carter Hewgley, Director of Homeless Initiatives.

- Carter Hewgley presented on United Way's Home for Good Approach and the
  organization itself. The HFG Approach is how United Way looks to create a unified
  vision to end homelessness. He and his team are focused on the inside policy work
  that include speaking with experts and decision-makers, investment of private funds
  into public goods with the goal of being transparent about progress and policy made.
  - The strategies that are deployed look at 10 concepts as stated in the slides.
     The goal is to help find ways to improve the life of the unhoused community by using funding for immediate solutions through alternative housing initiatives.
     Some other concepts the United Way looks to provide help is through funding of other daytime services.
  - Notably the aging population have been found to be on the verge of homelessness.
  - United Way also has hired KPMG to perform an evaluation comparing other non-profit organizations on workforce issues. Many have been impacted with the "great resignation" that has led to an increase in demand for services and a decrease in staff and disruption in the overall service provided.
  - With the sunset of Measure H funding nearing, they have begun to strategize what steps may be taken to have it renewed.
- Vice-Chair Desiree Rew thanked the two presenters and asked about the KPMG analysis.
  - Carter Hewgley replied that in comparison to other CoCs workforce, staff are new and only stay an average of 2 years.

#### UNSHELTERED HOMELESSNESS RESPONSE PLAN PRESENTATION

Paul Duncan, Homeless Services Bureau Manager, presented on the HUD Unsheltered/Rural Homelessness Notice of Funding Opportunity.

- HUD announced a new NOFO that is tailored to help people experiencing unsheltered homelessness as they are at a higher risk of health challenges and physical danger.
   The federal government's focus is on the continued push to advance equity and Housing First approach.
- The City of Long Beach is eligible for 5.2 million dollars over the span of three years. This funding may be extended if additional funding is presented.
- It is a highly competitive competition that will require community sessions, letters of support, request for proposals of new projects and a strict deadline to meet the final application date of October 20,2022.

#### HOMELESS SERVICES STAFF REPORT

Paul Duncan, Homeless Services Program Officer, provided an update

- He made a special note that the request for response of services continues to go up month after month.
  - The MSC has set a 5 new person cap per case manager a day
  - They often maxed out on new case management referrals daily
- Two new staff started in August and a few more still in the pipeline.
- A new lease will be signed on an office building for the admin/outreach teams located in Downtown due to the lack of office space at the MSC.
- There is a continued effort to expand partnerships with other motels willing to take additional vouchers for the encampment resolution program.
- A new service provider has been selected to oversee the ABC shelter as of August. First to Serve has the experience and has previously worked with the County of Los Angeles.
- Added a new location for outreach every 3rd Saturday of the month at St. Luke's.
- The Annual Continuum of Care Notice Of Funding Opportunity has been announced with the shortest timeline to apply, due at the end of September.
- Budget updates include
  - Approval for 1 additional REACH team
  - Expanded and weekend hours to call for service at the MSC
  - Fiscal commitments to pursue opportunities that can expand shelter and housing
- Emergency Shelter vouchers:
  - 588 vouchers currently issued.
  - Currently 421 active and searching, 167 leased up as of 8/1/2022
  - 317 intensive case management
- Joel Reynoza, Homeless Resource Coordinator, provided an update on Outreach
  - Outreach direct phone number, 562-470-4672(4MSC) is live and taking calls
    - 275 requests for outreach, 92 from the non-emergency dispatch
    - 274 recorded contacts
    - 27 tidelands/weekend outreach
    - 506 first time visitor to the MSC
    - 3428 total visits in the month of July
    - 189 average daily visit and increasing
- Member S. Jolene Hui wanted to comment on the high number of cases a caseworker is seeing a day and thanked the staff for their continued service to the

unhoused community.

- Chair Julie Lie asked for clarification of the Encampment Resolution Program's 1.2 million in MacArthur Park for non-congregate shelter.
