Agreement amount shall not exceed Sixty-Two Thousand Dollars (\$62,000), with a
 maximum increase of five percent (5%) annually and a ten percent (10%) contingency of
 Six Thousand Two Hundred Dollars (\$6,200), for a total annual amount not to exceed Sixty
 Eight Thousand Two Hundred Dollars (\$68,200).

3. Except as expressly modified herein, all of the terms and conditions
contained in Agreement No. 34731 are ratified and confirmed and shall remain in full force
and effect.


