FIRST AMENDMENT TO AGREEMENT NO. 35817

THIS FIRST AMENDMENT TO AGREEMENT NO. 35817 is made and entered, in duplicate, as of June 16, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 20, 2020, by and between Enterprise FM Trust, Inc., DBA Enterprise Fleet Management, Inc., a Missouri corporation ("Contractor"), with a place of business at 9315 Olive Boulevard, Saint Louis, Missouri 63132, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with lease vehicles for various Police operations ("Vehicles"); and WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35817 (the "Agreement") whereby Contractor agreed to provide these services; and WHEREAS, the Parties desire to add \$125,656 to the Agreement for a total not to exceed amount of \$251,312 and extend the term one (1) additional one-year period; NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.B. of the Agreement is hereby amended to read as follows.
- "1.B. Contractor shall lease Vehicles of substantially the same type and kind leased under the Sourcewell Contract, except as modified by Exhibit "B" attached hereto and incorporated by this reference, in an annual amount of One Hundred Twenty Five Thousand Six Hundred Fifty Six Dollars (\$125,656), inclusive of tax and fees, until the Sourcewell Contract expires on July 24, 2022. An additional One Hundred Twenty Five Thousand Six Hundred Fifty Six Dollars (\$125,656), inclusive of tax and fees, is added until the end of the new term ending July 24, 2023. To the extent that the Sourcewell Contract and this Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the Sourcewell Contract."
 - 2. Except as expressly modified herein, all of the terms and conditions
