



- On March 16, 2021, City Council approved the Long Beach Recovery Act (LB Recovery Act) to support recovery of residents and businesses from the pandemic
- Funding from Federal, State and County grants to be implemented through December 2024
- LB Recovery Act was based on 5 economic equity studies and feedback from 30+ listening sessions with over 350 community representatives






ABOUT THE LONG BEACH RECOVERY ACT


ABOUT THE LONG BEACH RECOVERY ACT


