Project Roomkey Update

- Project Roomkey located at the Days Inn was sunset on September 30th.
 Illumination Foundation along with the City were able to work with participants around transition plans. This was a challenging process as there were some people that had been at the site for 2 years
 - 6 People moved into permanent housing: 4 EHV, 2 to other PSH
 - 6 Participants were prioritized for openings at PHK based upon vulnerability
 - 3 Participants are temporarily staying with family and 3 are temporarily staying with friends
 - 3 People were supported in getting to a higher level of care SNF or assisted living
 - 1 Persons is temporarily being motel vouchered while working on a plan. 3 People chose to rent a motel with their own funds
 - 1 Person left and it is unknown where they are, and 1 person left declining a linkage to PHK
 - The remainder of the participants were linked with congregate shelter, mostly ABC



Operations Update Cont.

- First To Serve has begun as the shelter service provider and operator for the ABC shelter. The ABC site has gotten approval from LAHSA to start recompression of beds available. As of this week ABC will have 105 beds available for participants with the goal of getting to 125 beds in the next three weeks.
- Staff have begun to identify options for sites for the 2022 Winter Shelter program and working to partner with LAHSA to ensure that beds are available here in Long Beach.
- Sign-up for the 2023 homeless count will be posted within the next two weeks so that people can sign-up. HSB staff will send out an email alerting everyone that the link is available for sign-ups.



HUD NOFO Updates

- Long Beach submitted its FY-2022 Annual NOFO application. The application included 21 renewal project and 1 new DV Bonus proposals. We anticipate hearing about outcomes in early 2023.
- Long Beach is working through submitting a proposal for the Special Unsheltered NOFO. The proposals submitted will look to leverage funding opportunities the County, CalAIM and Housing Authority with the potential of bringing an additional \$10 million in services over a three-year period. Applications are due on October 20th and it is anticipated that awards would be announced in early 2023.



Emergency Housing Vouchers

- Long Beach has been allocated 582 Emergency Housing Vouchers
- 713 vouchers issued to date, with 487 that are active and searching
- 226 lease ups
- People are enrolled with intensive case management services
