FIRST AMENDMENT TO AGREEMENT NO. 36306

THIS FIRST AMENDMENT TO AGREEMENT NO. 36306 is made and entered into as of September 8, 2022, for reference purposes only, pursuant to a Minute Order adopted by the City Council of the City of Long Beach at its meeting on August 23, 2022, by and between VASQUEZ & COMPANY, LLP, a California limited liability partnership ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36306 (the "Agreement") whereby City requires specialized services requiring unique skills to be performed in connection with as-needed accounting services ("Project")

WHEREAS, the Parties desire to amend Agreement 36306 to increase the amount by \$13,350 for a revised total not to exceed \$223,350; and extend the term to November 30, 2022;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A of Agreement 36306 is hereby amended to read as follows:
 - A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed Two Hundred Twenty-Three Thousand Three Hundred Fifty Dollars (\$223,350), at the rates or charges shown in Exhibit "B".
- 2. Section 2 of Agreement 36306 is hereby amended to read as follows:
 - 2. <u>TERM</u>. The term of this Agreement shall commence at midnight on May 5, 2021, and shall terminate at 11:59 p.m. on November 30, 2022, unless
