THIS SECOND AMENDMENT TO AGREEMENT NO. 35386 is made and entered, in duplicate, as of October 10, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 20, 2019, by and between FORENSIC NURSING SPECIALIST, INC., a California corporation ("Consultant"), with a place of business at 10413 Los Alamitos Blvd., Los Alamitos, California 90720, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with providing medical examinations, evidence collection, and treatment for victims of sexual assault; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35386 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement for an additional one-year period; and

WHEREAS, the Parties desire to enter into a Second Amendment to extend the term for one (1) additional one-year period and update cost;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Agreement is hereby amended to read as follows.

"The term of this Agreement shall commence at midnight on October 31, 2019, and shall terminate at 11:59 p.m. on October 30, 2023."

2. Exhibit "B-1" to Agreement 35386 is hereby amended and replaced with Exhibit "B-2", attached hereto and incorporated herein.

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35386 are ratified and confirmed and shall remain in full force
