

1 FIRST AMENDMENT TO AGREEMENT NO. 36134

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 36134 is made and
4 entered, as of October 25, 2022, for reference purposes only, pursuant to a minute order
5 adopted by the City Council of the City of Long Beach at its meeting on October 19,
6 2021, by and between THE LITTLE LION FOUNDATION, a California nonprofit
7 ("Consultant"), with a place of business at 1179 E. Wardlow Road, Long Beach,
8 California 90807, and the CITY OF LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, City and Consultant ("Parties") entered into Agreement No.
10 36134 (the "Agreement") whereby City requires specialized services requiring unique
11 skills to be performed in connection with operating and managing a Kitten Nursery to
12 nurse Long Beach Animal Care Services provided kittens through to adoptable health
13 and age Project; and

14 WHEREAS, the Parties desire to extend the term for an additional one-year
15 period;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions
17 contained herein, the Parties agree as follows:

18 1. Section 2 of the Contract is hereby amended to read as follows:

19 "2. Term. The term of this Agreement shall commence on January 1,
20 2021, and shall terminate at 11:59 p.m. on December 31, 2023, unless sooner terminated
21 as provided in this Agreement, or unless the services or the Project is completed sooner.
22 The term may be extended for two (2) additional one-year periods, at the discretion of the
23 City Manager."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 36134 are ratified and confirmed and shall remain in full
26 force and effect.
