- "2. Term. The term of this Agreement shall commence on January 1, 2021, and shall terminate at 11:59 p.m. on December 31, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36134 are ratified and confirmed and shall remain in full force and effect.
