Authorize the General Manager to execute an Agreement with Lee & Ro, Inc., to provide construction management and inspection services for the J. Will Johnson Tanks Roof Repairs Project (EO-3630), in the amount not to exceed \$313,949.

Executive Summary

This Project is to perform roof repairs at J. Will Johnson Tanks 4, 5, 6, and 8. The scope of work includes the removal and replacement of roofing material, vent screening, roof hatches, guardrails, cathodic protection systems, and fall restraint systems of the tanks. The Consultant will inspect and perform construction management services to oversee the project.

On November 18, 2022, staff solicited proposals to provide construction management and inspection services for the J. Will Johnson Tanks Roof Repairs Project (EO-3630). Two proposals were received, evaluated, and analyzed. Staff recommends Lee & Ro, Inc., based on their comprehensive project approach, past experience on similar projects, and reasonableness of their fees. The not-to-exceed amount for their services is \$313,949 and the duration of the Agreement is through project completion.

Recommendation

Authorize the General Manager to execute an Agreement with Lee & Ro, Inc., to provide construction management and inspection services for the J. Will Johnson Tanks Roof Repairs Project (EO-3630), in the amount not to exceed \$313,949.

Fiscal Impact: The cost to the Water Fund will be incurred in FY 23, with the total amount will not exceed the contract total of \$313,949. These costs are included in the Water Fund FY 23 CIP Budget.
