FIRST AMENDMENT TO AGREEMENT NO. 36208

THIS FIRST AMENDMENT TO AGREEMENT NO. 36208 is made and entered, as of October 27, 2022, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 18, 2019, by and between JONES LANG LASALLE BROKERAGE, INC., a Texas corporation ("Consultant"), with a place of business at 2141 Rosecrans Avenue, Suite 6100, El Segundo, California 90245, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36208 (the "Agreement") whereby Consultant agreed to provide as-needed real estate economic analysis professional services; and

WHEREAS, the Parties desire to add \$70,000 to the Agreement and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Seventy Thousand Dollars (\$270,000), at the rates or charges shown in Exhibit "B"."
 - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on December 1, 2021, and shall terminate at 11:59 p.m. on May 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be renewed for two (2) additional one-year periods, at the discretion of the City Manager."
