ORDINANCE NO. ORD-23-0005

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING ORDINANCE NO. C-1015 TO REPEAL AND REMOVE FIVE-FOOT-SPECIAL SETBACK ALONG THE WEST SIDE OF LONG BEACH BOULEVARD WHERE IT FRONTS THE FIRE STATION NO. 9 PROJECT AT 4101 LONG BEACH BOULEVARD

The City Council of the City of Long Beach ordains as follows:

Section 1. Upon recommendation of the Planning Commission, it is the determination of the City Council that the public interest and general welfare require the amendment of the following ordinance to remove the five-foot-special setback along the west side of Long Beach Boulevard where it fronts the Fire Station No. 9 project at 4101 Long Beach Boulevard in the City of Long Beach. Henceforth, the setback provisions of the City's Zoning Regulations as set forth in the Long Beach Municipal Code shall apply to such property.

Section 2. The first paragraph of Section 1 of Ordinance No. C-1015 is amended to read as follows:


"Section 1. In the opinion of the City Council of the City of Long Beach, the public interest, peace, health, safety, comfort, convenience and welfare require, and said city council having acquired jurisdiction so to do, set back lines are hereby ordered established and are hereby established on private property boarding on both side of Long Beach Boulevard, in the City of Long Beach California, except as repealed at the real property shown on Exhibit A hereto and incorporated herein, as set forth below:"
