

FOURTH AMENDMENT TO AGREEMENT NO. 35527

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35527 is made and entered, as of February 13, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 21, 2020, by and between KARDENT, a California corporation ("Consultant"), with a place of business at 11 Golden Shore, Suite 540, Long Beach, California 90802, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35527 (the "Agreement") whereby Consultant agreed to provide as-needed space planning and architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$200,000 for a total not to exceed amount of \$300,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$100,000 for a total not to exceed amount of \$400,000 and extend the term to March 31, 2023; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$150,000 for a total not to exceed amount of \$550,000; and

WHEREAS, the Parties desire to add \$100,000 to the Agreement for a total not to exceed amount of \$650,000, and extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to the Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed Six Hundred Fifty Thousand Dollars (\$650,000), at the rates or charges shown in Exhibit

1 "B".

2 2. Section 2 of the Agreement is hereby amended to read as follows:

3 "2. TERM. The term of this Agreement shall commence at midnight on
4 April 1, 2020 and shall terminate at 11:59 p.m. on March 31, 2024, unless sooner
5 terminated as provided in this Agreement, or unless the services or the Project is
6 completed sooner. The term may be renewed for one (1) additional one-year period, at
7 the discretion of the City Manager."

8 3. Except as expressly modified herein, all of the terms and conditions
9 contained in Agreement No. 35527 are ratified and confirmed and shall remain in full force
10 and effect.
