

SECOND AMENDMENT TO AGREEMENT NO. 35567

THIS SECOND AMENDMENT TO AGREEMENT NO. 35567 is made and entered, as of February 3, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 21, 2020, by and between LA CANADA DESIGN GROUP, INC., a California corporation ("Consultant"), with a place of business at 630 N. Rosemead Blvd., Suite 400, Pasadena, California 91107, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35567 (the "Agreement") whereby Consultant agreed to provide as-needed space planning and architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$50,000 for a total not to exceed amount of \$100,000 and extend the term to March 31, 2023; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on April 1, 2020 and shall terminate at 11:59 p.m. on March 31, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be renewed for one (1) additional one-year period, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35567 are ratified and confirmed and shall remain in full force and effect.
