THIS SEVENTH AMENDMENT TO AGREEMENT NO. 33926 is made and entered, in duplicate, as of March 8, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 5, 2022, by and between ARCHITECTS MCDONALD, SOUTAR & PAZ, INCORPORATED, a California corporation ("Consultant"), with a place of business at 3575 Long Beach Blvd., Long Beach, California 90807, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33926 (the "Agreement") whereby Consultant agreed to provide as-needed architectural services in a total not to exceed amount of Four Hundred Thousand Dollars (\$400,000) for a period of two (2) years with the option to extend for three (3) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to July 19, 2018; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add Two Hundred Thousand Dollars (\$200,000) for a total not to exceed amount of Six Hundred Thousand Dollars (\$600,000) and extend the term to July 19, 2019; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to July 19, 2020; and

WHEREAS, on June 9, 2020, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to July 19, 2021; and

WHEREAS, on June 8, 2021, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to

WHEREAS, the Parties entered into a Sixth Amendment to add Two Hundred Fifty Thousand Dollars (\$250,000) for a total not to exceed amount of Eight Hundred Fifty Thousand Dollars (\$850,000), extend the term one (1) additional one-year period, update the City Representative and attach an updated rate sheet;

WHEREAS, Parties desire to add Two Hundred Thousand Dollars (\$200,000) for a total not to exceed One Million Fifty Thousand Dollars (\$1,050,000) to the Agreement:

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 1.A. of the Agreement is hereby amended to read as follows: Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Fifty
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33926 are ratified and confirmed and shall remain in full force and effect.
