

EIGHTH AMENDMENT TO AGREEMENT NO. 34491 **34491**

THIS EIGHTH AMENDMENT TO AGREEMENT NO. 34491 is made and entered, in duplicate, as of January 18, 2023, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 17, 2023, by and between ABM AVIATION, INC. formerly known as ABM PARKING SERVICES, INC., a Georgia corporation, with a place of business at 1150 South Olive Street, Los Angeles, California 90015 ("Operator"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Operator (the "Parties") entered into Agreement No. 34491 (the "Agreement") whereby Operator agreed to perform services in connection with airport parking operations and management at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$263,531 to the first year of the Agreement; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to reflect the name change and add \$269,354 to the second year of the Agreement; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$1,400,640 to the third year of the Agreement; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add \$1,446,862 to the fourth year of the Agreement and extend the term to November 30, 2020; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to add \$1,493,161 to the fifth year of the Agreement and extend the term to November 30, 2021; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to add \$1,657,207 to the sixth year of the Agreement and extend the term to November 30, 2022; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to add \$350,000 for a total not to exceed amount of \$9,047,391 and extend the

1 term to February 28, 2023; and

2 WHEREAS, the Parties desire to add \$350,000 plus a ten percent
3 contingency in the amount of \$35,000 for a total not to exceed contract amount of
4 \$9,432,391 and extend the term an additional two months;

5 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
6 conditions herein contained, the Parties agree as follows:

7 1. The Agreement amount shall be increased by Three Hundred Fifty
8 Thousand Dollars (\$350,000), with a ten percent (10%) contingency in the amount of
9 Thirty-Five Thousand Dollars (\$35,000), for a total not to exceed amount of Nine Million
10 Four Hundred Thirty-Two Thousand Three Hundred Ninety-One Dollars (\$9,432,391).

11 2. Section 2 of the Agreement is hereby amended to read as follows:

12 "2. TERM. The term of this Agreement shall commence at midnight on
13 December 1, 2016, and shall terminate at 11:59 p.m. on April 30, 2023, unless sooner
14 terminated as provided in this Agreement."

15 3. Except as expressly amended in this Amendment, all terms and
16 conditions in Agreement No. 33491 are ratified and confirmed and shall remain in full force
17 and effect.
