 "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in a total contract amount not to exceed One Hundred Thousand Dollars (\$100,000), at the rates or charges shown in Exhibit "B"."

2. Section 2. of the Agreement is hereby amended to read as follows.

"2. TERM. The term of this Agreement shall commence at midnight in December 1, 2020, and shall terminate at 11:59 p.m. on November 30, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City manager."
