## THIRD AMENDMENT TO AGREEMENT NO. 35378 35378

THIS THIRD AMENDMENT TO AGREEMENT NO. 35378 is made and entered, in duplicate, as of February 2, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 17, 2019, by and between MEDEX MANAGED CARE, INC. a California corporation ("Medex"), with principal offices at 1201 Dove Street, Suite 300, Newport Beach, California 92660, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Medex (the "Parties") entered into Agreement No. 10 35378 whereby Medex agreed to provide managed care services, specifically utilization review; and 11

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to update the Scope of Services; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term one (1) additional one-year period to September 30, 2022; and 15

16 WHEREAS, the Parties desire to extend the term one (1) additional one-year 17 period to September 30, 2023;

18 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 19 conditions herein contained, the Parties agree as follows:

1. Section 1 of the Agreement is hereby amended to read as follows:

21 "1. EFFECTIVE DATE AND TERM. This Agreement shall begin on October 1, 2019 and shall end on September 30, 2023 (both days inclusive), unless 22 23 terminated earlier in accordance with Section 12. By mutual agreement and amendment 24 of this Agreement, the parties may extend the term for one (1) separate, consecutive period 25 of one year."

26 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33578 are ratified and confirmed and shall remain in full force 27 28 and effect.


