### **EXECUTIVE STAFF REPORTS**

**2.** 23-013BH Recommendation to receive and file a report from the Director of Health and Human Services.

Kelly Colopy, Director of Health and Human Services, provided the Board with the following information:

- The Department will celebrate Public Health Week the week of April 3 9, 2023. Various events will be held that week, and a calendar of events will be shared with the Board once finalized. Ms. Colopy provided the Board with a save the date for the Department's Public Health Conference which will be held on April 6th at the Long Beach Airport Marriott. Invitations will be forthcoming.
- The Governor's Budget proposes substantial cuts to the Heroes Fund, which provides for Public Health workforce development.
- Kelly's attendance at the Big Cities Health Coalition in-person meetings in Washington, DC.
- The City's has officially ended the COVID-19 Emergency. Ms. Colopy

briefly discussed the loss of funding for staff hired with federal COVID funds. Ms. Colopy discussed efforts to keep these staff wherever possible, either through transition to other positions or by seeking additional funding opportunities to cover those staff.

- The City's ongoing Homeless Emergency. There was a brief discussion of the City's attempt to open an emergency homeless shelter at Silverado Park. The winter shelter located at Community Hospital will be extended by one additional month due to ongoing inclement weather. Ms. Colopy also briefly discussed the creation of 60 warming beds at the City's Multi-Service Center in response to cold, wet weather.
- The Department's Central Facilities Center is undergoing needed repairs and upgrades.
- A brief conversation regarding efforts to transform the former Community Hospital site into a wellness campus, providing needed health and wellness services.

#### **3.** 23-014BH

Recommendation to receive and file a report from the City Health Officer on Communicable Disease Control activities.

Anissa Davis, City Health Officer, provided the Board with the following information:

- The City ended its COVID-19 emergency on February 21st, and the State ended its emergency declaration on February 28th. The federal government will officially end its emergency declaration on May 11th.
- Changes to Medi-Cal reenrollment requirements and a reduction in CalFresh / SNAP financial assistance amounts.
- Changes to the State's COVID-19 Health orders regarding isolation guidance, masking, and vaccination mandates. The City will be aligning with Los Angeles County to continue the vaccination requirements for healthcare workers and the masking requirement for healthcare workers providing direct patient contact.
- The illicit use of Xylazine, also known as tranq, which was primarily affecting communities on the east coast, but is now showing up locally.
