THIS FOURTH AMENDMENT TO AGREEMENT NO. 34907 is made and entered, in duplicate, as of March 22, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 17, 2023, by and between HDR ENGINEERING, INC., a Nebraska corporation ("Consultant"), with a place of business at 1917 South 67th Street, Omaha, Nebraska 68106, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34907 (the "Agreement") whereby Consultant agreed to provide on-call professional engineering and architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to decrease the Agreement amount by \$250,000 for a total not to exceed amount of \$250,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$50,000 for a total not to exceed amount of \$300,000, and extend the term to February 28, 2022; and

WHEREAS, the Parties entered into a Third Amendment to extend the term to February 28, 2023; and

WHEREAS, on January 17, 2023, the City Council authorized extending the Agreement term for an additional three-year period, with the option to renew for two additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties desire to extend the term of the Agreement by an additional three (3) years, with the option to renew for two additional one-year periods, at the discretion of the City Manager, update the rates and update the City's Representative;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

 TERM. The term of this Agreement shall commence at midnight on
March 1, 2018, and shall terminate at 11:59 p.m. on February 28, 2026, unless sooner
terminated as provided in this Agreement, or unless the services or the Project is
completed sooner. The term may be extended for two (2) additional one-year periods, at
the discretion of City Manager."

- 2. The rates in Exhibit "B" to the Agreement are hereby amended in accordance with Exhibit "B-1", attached hereto and incorporated by this reference.
- 3. The City's Representative in Exhibit "C" to the Agreement is hereby amended in accordance with Exhibit "C-1", attached hereto and incorporated by this reference.
- 4. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34907 are ratified and confirmed and shall remain in full force and effect.
