## FOURTH AMENDMENT TO AGREEMENT NO. 35221

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35221 is made and entered, in duplicate, as of February 7, 2023, for reference purposes only, pursuant to minute orders adopted by the City Council of the City of Long Beach at its meetings on March 5, 2019 and November 17, 2020, by and between AECOM TECHNICAL SERVICES, INC., a California corporation ("Consultant"), with a place of business at 401 West A Street, Suite 1200, San Diego, California 92101, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35221 (the "Agreement") whereby Consultant agreed to provide on-call environmental, planning, affordable housing, and community engagement consultant services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to March 5, 2022 and update Consultant's key employee; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$50,000 for a total not to exceed amount of \$100,000; and

WHEREAS, the Parties entered into a Third Amendment to add \$350,000 to the Agreement for a total not to exceed amount of \$450,000 and extend the term to March 5, 2023; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2 of the Agreement is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on March 6, 2019, and shall terminate at 11:59 p.m. on March 5, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
