## THIRD AMENDMENT TO AGREEMENT NO. 35323

## 

THIS THIRD AMENDMENT TO AGREEMENT NO. 35323 is made and entered, as of May 1, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 18, 2019, by and between BAE URBAN ECONOMICS, INC., a California corporation ("Consultant"), with a place of business at 2560 Ninth Street, Suite 211, Berkley, California 94710, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35323 (the "Agreement") whereby Consultant agreed to provide as-needed real estate economic analysis professional services for a period of two (2) years with the option to extend for three (3) additional one-year periods, in the amount of \$50,000; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to May 31, 2022; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to May 31, 2023; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on June 1, 2019, and shall terminate at 11:59 p.m. on May 31, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 2. Except as expressly amended herein, all terms and conditions in Contract No. 35323 are ratified and confirmed and shall remain in full force and effect.
