## THIRD AMENDMENT TO AGREEMENT NO. 35268

THIS THIRD AMENDMENT TO AGREEMENT NO. 35268 is made and entered, as of April 7, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 18, 2019, by and between FLEET COLLISION SERVICES, INC., a California corporation ("Contractor"), with a place of business at 14833 Lakewood Bivd., Paramount, CA 90723, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with light and medium vehicle body repair ("Project"); and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35268 (the "Agreement") whereby Consultant agreed to provide these services as described in Request for Proposals number FS19-042; and

WHEREAS, the Parties entered into a First Amendment to increase the annual contract amount and renew the contract for an additional one-year period and;

WHEREAS, the Parties entered into a Second Amendment to increase the contract amount and renew the contract for an additional one-year period and;

WHEREAS, the Parties desire to enter into a Third Amendment to increase the contract amount by an additional Eight Hundred Thousand Dollars (\$800,000) and extend the contract for one (1) additional one-year term until July 31, 2024;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 1.A. of the Agreement is hereby amended to read as follows:
   "SCOPE OF WORK OR SERVICES.
- A. Contractor shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Five Hundred Fifty

of Eighty-Two Thousand Five Hundred Dollars (\$82,500), for a total annual amount not to exceed Six Hundred Thirty-Two Thousand Five Hundred Dollars (\$632,500), for the term July 1, 2029 to June 30, 2021, at the rates or charges shown in Exhibit "B". For the term July 1, 2021 to June 30, 2022, the annual not to exceed amount shall be Six Hundred Thousand Dollars (\$600,000). For the term July 1, 2022 to June 30, 2023, the annual not to exceed amount shall be Eight Hundred Thousand Dollars (\$800,000). For the term July 1, 2023 to June 30, 2024, the annual not to exceed amount shall be Eight Hundred Thousand Dollars (\$800,000)."

2. Section 2 of the Agreement is hereby amended to read as follows:

Thousand Dollars (\$550,000) annually, with a 15 percent contingency in the amount

"TERM. The term of this Agreement shall commence at midnight on July 1, 2019, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as provided herein. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35268 are ratified and confirmed and shall remain in full force and effect.
