Pacific Coast Highway, Long Beach, 8 California 90803 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 10 36156 (the "Agreement") whereby Contractor agreed to provide specialized services 11 requiring unique skills to be performed in connection with maintenance and management 12 of environmentally sensitive areas along the tidelands areas and environmental tasks, 13 including interpretive education, coordination of volunteer groups, and bird surveying counting for various tidelands areas ("Project"); and 14

15 WHEREAS, the Parties entered into a First Amendment to clarify the annual 16 not to exceed amount of Six Hundred Ninety-Nine thousand Six Hundred Sixty Dollars 17 (\$699,660); and

WHEREAS, the Parties desire to extend the term for an additional one (1) 18 19 year period until June 30, 2024;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 21 conditions herein contained, the Parties agree as follows:

5	term may be extended for two (2) additional one-year periods, at the discretion of the City
6	Manager."
